

## CONTENT OF MANAGEMENT OF PRESCHOOL EDUCATIONAL ORGANIZATION

## Abstract

This article states that preschool education is the first stage of the system of continuous education and that preschool education is carried out on the basis of decisions, orders, resolutions of the Ministry of Preschool Education of the Republic of Uzbekistan, "Organization of preschool education and its Charter.

**Keywords:** preschool education, organization, additional education, activity, decisions of the ministry, orders, directives, development.

## Introduction

Preschool education is the first stage of the system of continuing education, the most important part of social education. Preschool education plays a leading role in educating children, identifying and developing their abilities, and preparing them for school. Preschool education organization includes the Constitution and laws of the Republic of Uzbekistan, decrees, resolutions, orders of the President of the Republic of Uzbekistan, resolutions and other documents of the Oliy Majlis of the Republic of Uzbekistan, resolutions and orders of the Cabinet of Ministers of the Republic of Uzbekistan. Resolutions, orders, decrees of the Ministry of Preschool Education of the Republic of Uzbekistan, the Regulation "On the organization of the activities of preschool education organizations" and its Charter. The preschool education organization has the right to make independent decisions related to its activities, which do not contradict the current legislation and pedagogical principles. It is organized to meet their needs for upbringing and development as well-rounded people.

The organization of preschool education is responsible for the quality and effectiveness of educational work, respect for the rights of children and parents, society and the state in this regard. Preschool education groups are organized at mixed-type orphanages. The status, educational criteria and principles of such groups are determined by the relevant regulations. The educational process in different types of preschool organizations is carried out on the basis of normative documents and guidelines approved by the Ministries of Preschool Education and Health. Their





content is also described in detail in the Concept on Preschool Education and the Regulations on the Organization of Preschool Education.

According to the current legislation, the preschool organization pays special attention to the provision of medical care to children. Medical care is provided by the staff of the health department attached to the institution or by the medical staff (nurses) working in the organization.

Along with the administration of the organization, health workers ensure the health and physical development of children, conduct treatment and prevention activities, educators and students follow the rules of sanitation and hygiene, the quality of food and nutrition, children's health. The local health departments are responsible for overseeing the activities of the medical staff working in the preschool education organization. will be registered on the board with the appropriate serial number. Once registered, it has the right to become a legal entity. is done. This decision is made in consultation with the organization's work team and the Preschool Education Council. The preschool organization approves state units and salaries, depending on the type, structure, and affiliation.

The main tasks of the Parents' Committee are set out in the charter of the preschool organization. The preschool organization has the right to choose one of the multivariate educational programs approved by the Ministry of Preschool Education of the Republic of Uzbekistan. Preschool education is an educational institution that provides qualified education in accordance with the concept, regulations and program, in addition to social tasks. Preschool education organization develops its own program and methods of work and has the right to apply in practice. Their approved procedure is determined by the Ministry of Preschool Education. The educator of the preschool organization has the right to freely choose the methodological manuals for the upbringing and education of children. Establishment of specialized preschool educational institutions and creation of new types of special preschool educational institutions for children with developmental disabilities shall be determined by the republican bodies of preschool education management and health care. Specialized preschool educational institutions The rules of admission, organization of education and upbringing of children are determined by the relevant instructions approved by the Ministry of Preschool Education and the Ministry of Health of the Republic of Uzbekistan.

Creating a preschool organization. Children from 3 to 6-7 years of age are admitted to preschool education. Admission of children to preschools, the founders of which are local public authorities, is carried out on the basis of referrals from the Center for Public Services. Admission of children to preschool educational institutions, the





founders of which are other bodies, is carried out in the manner prescribed by their founders. If there are vacancies, these preschools can accept children on a contract basis with referrals from the Preschool Education Departments.

Organizational structure and characteristics of different types of preschool education. The number of groups in a preschool organization is determined by the founder based on the capacity of the organization and the planned replenishment of groups. In a preschool, the school year begins on September 2 each year, ends on May 31 of the following year, and the recovery period begins before the start of the new school year. Referral of children to preschool educational institutions and specialized groups is provided by the republican, regional, city, district medical and pedagogical commissions, and to sanatorium-type preschool educational institutions by the regional treatment and prevention institution. expulsion by the Council of Preschool Education in the following cases: on the basis of a medical report that prevents the child from remaining in the preschool institution; if the child does not come to the preschool for more than a month without a reason; two weeks have passed since the deadline for payment for its services; at the discretion of the parents or guardians. Parents will be notified of the child's expulsion from the organization 7 days in advance. Expulsion of a child from a pre-school educational institution due to a change of parent's place of work is strictly prohibited, unless otherwise specified in the contract. The relationship between educators and parents based on these norms is governed by applicable law and by mutual agreement of the parties when the child is admitted to a preschool institution, governed by a contract. Failure to fulfill the obligations under the contract can be appealed to the Board of Preschool Education or the court. The preschool organization has its own charter, bank account, a stamp with the image of the State Emblem of the Republic of Uzbekistan and its name, a stamp with the legal address.

Accreditation of a preschool educational institution is carried out by the authorized state body on the basis of attestation. The pre-school education organization shall ensure the upbringing, education, care and rehabilitation of children in accordance with the established state standards and the requirements of the pre-school educational institution. The content of education in preschool educational institutions is determined by the programs approved or recommended by the Ministry of Preschool Education of the Republic of Uzbekistan. The preschool has the right to use its (author's) program. The procedure for approving such programs is determined by the ministry of the Ministry of Preschool Education. The order and duration of the working day of the preschool educational institution is determined by the charter of the institution and





the decision of the founder. The preschool organization (group) is allowed to operate during the day and in the evening, as well as around the clock.

Education and upbringing of children in preschool education is carried out in the state language and in other languages in accordance with the Law of the Republic of Uzbekistan "On the state language". It is carried out by medical personnel of law enforcement agencies. Together, they are responsible for the life, health and physical development of children, the implementation of treatment and prevention measures, compliance with sanitary and hygienic standards, the agenda and quality of nutrition. Local health authorities are responsible for overseeing the activities of medical staff. The pre-school education organization provides a separate room for the health worker and creates appropriate conditions for his / her effective work. State staff of the preschool organization will receive a free medical examination at the health facilities, which will be funded by the state.

The procedure for organizing the protection of life and health of children in preschool educational institutions is determined in cooperation with the Ministry of Preschool Education and the Ministry of Health of the Republic of Uzbekistan. Preschool education has the right to provide additional paid educational services in addition to the basic educational programs, taking into account the needs of the family on the basis of agreements with parents or guardians to fulfill the goals and objectives set out in the charter of the organization . Paid educational services may not be provided within the framework of basic educational activities funded by the founder. The procedure for forming the staff of the preschool organization is determined in accordance with the standard staffing table. In general, the management of a preschool organization has the right to engage in pedagogical activities only those who have the appropriate pedagogical education, professional training and high moral and ethical qualities.
