In accordance with the current legislation, local representative bodies of state power in our country are formed through general elections, which are considered an independent body in their activities. The Senate will only assist in improving their activities, provide methodical assistance.

To this end, a number of works are being carried out by the Senate in order to effectively organize the activities of local councils, provide them with methodical support, improve the practical skills of Deputies.

Current legislation at the same time, it is not surprising that the strengthening of the rule on cancellation by the Senate of the Oliy Majlis of the Republic of Uzbekistan in accordance with the established procedure of decisions of the Regional, District, City Councils of people's deputies contrary to the Constitution and laws of the Republic of Uzbekistan, decrees, resolutions and orders of the President

In addition, the commission of the Oliy Majlis of the Republic of Uzbekistan, which promotes the activities of the Senate of local authorities, further improving cooperation with local councils of people's Deputies of the Senate in solving the tasks of socio-economic development of regions, providing practical and methodical assistance to the permanent commissions of local councils of people's deputies in, it was also established in order to increase the responsibility of the heads of their



permanent commissions in the effective organization of the activities of local councils of people's deputies".

As a result of the reforms carried out in recent years, the accountability of the heads of local government before the local representative bodies of the state power in order to establish effective parliamentary control over the local executive power has been further strengthened year after year and year after year.

In 2021, in the councils of people's Deputies of the regions and cities of Tashkent and all districts (cities), secretaries operating on a permanent basis were established. This in its place serves to increase the efficiency of the activities of local councils.

In addition, in order to formulate the skills of effective communication with the population for Deputies of local councils, to form the local budget and carry out its control, as well as to carry out effective parliamentary control over the socio-economic development of territories, to organize hearings of reports by representatives of executive bodies, to ensure legitimacy in decision-making, trainings, seminars were Today, the regional representative body of the state authority is the Senate of the Oliy Majlis of the Republic of Uzbekistan as the regional representative body in methodical maintenance of activities of local representative bodies.

In order to discuss the issues of socio-economic development of the territory and the most important problems, a joint session of the Senate (commissions) and the local council of the Oliy Majlis of the Republic of Uzbekistan can be held the introduction of the rule on the league became the same term.

In accordance with the law of the Republic of Uzbekistan "on the introduction of amendments to certain legislative acts of the Republic of Uzbekistan in connection with the improvement of activities of the councils of people's deputies"dated September 14, 2020, it is desirable to make effective use of the opportunities of the secretariat of the Council of people's deputies included

The Senate of the Oliy Majlis of the Republic of Uzbekistan prepares methodical manuals on the proper and effective organization of the activities of Deputies of local councils, effective organization of Secretaries 'activities, the request of Deputies is delivered to each local council deputy.

The meeting with the chairman of the Senate of the Oliy Majlis of the Republic of Uzbekistan and his deputies, Senate committees and commissions, visits of members of the Senate to the regions was organized and discussed issues related to increasing the effectiveness of the activities of the councils.

Also, with the aim of providing practical and methodological assistance to local councils in a permanent way, establishing constant dialogue with them, the Senate is



constantly moving to the place of senators working on a permanent basis, providing practical assistance to the activities of local councils.

According to the results of monitoring conducted in order to improve the activities of local representative bodies of state power, it was found out that there are the following common shortcomings inherent in their activities:

- People's deputies always pay attention to the requirements related to strict noncompliance with the regulations of local councils, non-compliance with the rules of holding sessions, sending relevant documents to the deputies of the council before the opening of the session;
- There is no effective mechanism of control over the execution of decisions of local councils of people's deputies and its permanent commissions;
- There is no analytical data on the implementation of decisions of local councils of people's deputies;
- Some local councils of people's deputies did not pay attention to the timely implementation of the activities established by permanent commissions in the work plans. As a result, it remains only on paper.

After All, Our President Sh. Mirziyoyev noted "" it is necessary to further develop the cooperation of the Senate with local councils, their activities in providing practical and methodical support to their activities.

Unfortunately, today the activities of our upper chamber in this regard remain sluggish. The most sad thing is that local councils practically do not use their powers in finding solutions to pressing issues in the regions".

Taking into account this, despite the fact that a number of works have been carried out by the Senate in recent years in order to effectively organize the activities of local councils, provide them with methodical support, improve the practical skills of Deputies, it is desirable to carry out the following in order to further enhance the activities of the representative bodies of:

**first of all**, the organization of training by developing special programs at the Academy of Public Administration under the president of the Republic of Uzbekistan in the field of increasing practical skills and political and legal consciousness of Deputies constantly working in the local councils of people's deputies, employees of the Council of labor activity;

**secondly**, to further improve the organizational and legal framework of interaction of the Senate with local representative bodies of state power, to actively involve subjects of public control and mass media in these processes;

**third,** to establish the practice of conducting meetings of the plenary sessions of the Senate of the Oliy Majlis of the Republic of Uzbekistan, as well as the meetings of the

Senate departments and commissions in the regions in terms of the need to consider and solve the regional problems on the spot;

**of the four,** the order of listening to the reports of the heads of enterprises, institutions and organizations in the localities, in the implementation of their supervisory functions of the local council of people's deputies and their permanent commissions, ensuring the participation of senators elected from the territories and paying serious attention to it, appropriate assessment of the activities of a particular; **from the fifth,** to monitor the activities of each local council, to ensure their organizational and methodological activities and to use modern information and communication technologies;

In summary, the practice of the local representative bodies of the state power on the effective exercise of the right to solve territorial issues within the framework of the country's supreme representative body has shown that there are a number of problems in this area, the timely finding of a legal solution to these problems will undoubtedly serve to increase
