This case is called dogmatism in the scientific language. It means that human knowledge must always grow in harmony with life itself.

The worldview is a sub-reality, which is formed throughout the life of a person. Worldview covers emotions, feelings-e'tiqod knowledge, practical activity, confidence to include. For example, young people see their worldview in real-life implementation strategies. In this sense, it is clear that in time, instead of religion, the scientific worldview also appeared on the stage of history, in accordance with the Universal evolutionary logic. At the same time, the universal crisis caused by the practice of science of the present period also shows that it is not surprising that scientists are accused of infidelity.

It seems that the only philosophical basis that can be the basis for solving cross-sectional problems before humanity, the formation of the science of single-leader wisdom, remains an armon for the wise, is the uniqueness, unfathomable diversity, dissociation into different currents and the sharp contradictions between them, especially materialism and idealism, manifested in the history of philosophical thought.
