



## THE CONTENT OF IMPROVING THE SOCIAL ACTIVITY OF STUDENTS

### Introduction

The analysis of our scientific observations in the system of Higher Education shows that when improving the social activity of students, teachers and tutors should take into account the following:

- The purpose of social activity should be studied as a result of in-depth analysis of social order, science, educational programs, event plans by the educator according to the content of spiritual–educational, educational, educational activities; (goals set by teachers and tutors should serve to improve the social activity of students)
- On the basis of pedagogical neology, the tasks and goals set for improving the social activity of students should be clear and somewhat complex in accordance with the requirements of modernized education, this goal should primarily serve to develop students intellectually, spiritually, morally, physically, aesthetically and mentally;
- Increasing social activity, ensuring students' participation in public works depending on their individual characteristics, worldview and abilities, encouraging them based on the results of their activities;
- On the basis of "integrative cooperation" formation of the culture of students' work with educational, scientific, methodical literature; (continuous education system- Youth Union of Uzbekistan-)
- Increasing the importance of spiritual-educational, national-religious traditions in educating students in a comprehensive manner, encouraging them to be socially and creatively active has an important pedagogical significance.

In our opinion, it is time to raise the social activity of students on the basis of pedagogical neology, to form in them a worldly, religious, and material worldview in a colorful social life, to increase their activity in public affairs, to pay serious





attention to the issues of healthy lifestyle culture and meaningful organization of students' free time.

Cultivating social activity is not only an increase in the level of participation in public affairs, but also the formation of motives that determine the moral orientation of young people. From this point of view, the need to implement the strategy of spiritual and educational reforms based on the neological approach to increase the social activity of students and to improve all areas of the education sector is evident. In the scientific research of A.A. Rakhimov, it was shown that this necessity can be realized with the help of the following tasks of spiritual and educational activity.

First:

- To support the development of spiritual culture on the basis of free and healthy competition, to prevent information attacks and influence on the idea of national independence;
- Protection and improvement of the spiritual and educational sphere.....

Secondly:

- To provide students with an understanding of the historical roots, theoretical and practical directions of independence;
- Strengthening the importance of forming the spiritual culture of students in social institutions and public activities;.....

It can be concluded from the opinions expressed that it is important to attract students to public works, to increase their activity in public works, directly and indirectly, to increase the effectiveness of spiritual and educational activities.

Our observations and experiences show that 90 percent of students in the higher education system turn to the Internet as the main source of information, mainly social networks such as "Google scholar", "Youtube", "Twitter", "Instagram", "Facebook", "Telegram", "Odnoklassniki". they spend their free time on networks and video and audio portals. It is no secret that only a certain part of the Internet information that students are engaged in consists of non-harmful scientific, cultural and educational sites.

Kusherbaev, deputy of the Legislative Chamber of the Oliy Majlis, wrote in an internet article that there are 9,000 sites on the Internet promoting easy ways to commit suicide, and more than 4,000 sites with sexual content, while 49% of computer games promote violence and evil. At the same time, 42 percent of children and teenagers, students and young people are totally subject to the influence of pornography distributed online. International experts confirm that 38 percent of children regularly access websites with a spirit of violence, and 26 percent access websites of a nationalist nature. The mentioned issues are directly among the problems of every young person





taking their place in the social and political life of the country and forming a citizenship position.

We logically continued the ideas of R. Kuserbaev and at the same time recognized that improving the social activity of students on the basis of pedagogical neology is an urgent pedagogical problem in the higher education system. Improving students' social activity based on pedagogical neology, on the one hand, serves to increase students' activity, the most important and general characteristic of a person, which maintains constant relations with society, self-awareness and coordinates every movement, and on the other hand, it helps students to form a civic position, ideological in addition to strengthening immunity, forming social consciousness, having an independent personal opinion, it has an important social importance in the development of enlightenment and the rise of society.

In our opinion, one of the important components of improving social activity among young students is the education of their social consciousness. We know that social consciousness is the process of socialization of a person for the development of society (socio-political, economic, cultural-educational, ideological-ideological development of society) to conscious activity, the image of real life accepted by the student, including the level of the child's correct perception of the external environment, is the process of preparing the child to contribute to the development of society. So, along with social changes, social consciousness is changing and developing. Based on this, on the basis of pedagogic neology, the social activity of students is improved on the basis of their conscious discipline, thinking and outlook, national and universal culture. The second important component is the development of effective, creative and innovative methods of formation of national and universal culture among students. In the rapidly changing world, the creation of national and universal culture in preparing students for a successful social life, forming in them such qualities as responsibility, commitment, legal awareness and legal culture, deep worldview, healthy faith, enlightenment, religious and national tolerance, spiritual, civil, intercultural, social flexibility. is important.   - Along with independent and free thinking, a creative approach to the development of scientific and creative abilities;
  - The formation of a scientific worldview and the competence of global thinking;
- He should actively participate in all parameters specified in the concept of development of the higher education system.

From this point of view, the organization of issues of ensuring the quality of education in the higher education system on the basis of international standards and requirements is the focus of the head of our state, and there are 4 priority tasks in the field: they emphasized the need to create an environment for working on it. Therefore, the strategic directions of the organization of the continuous education system based on "digital technologies", the development of effective, creative and innovative methods, promotion work on the wide involvement of foreign citizens to study in our country, including PR-projects (organization of days of higher education institutions of Uzbekistan, presentations transfer, etc.) to create an interactive virtual platform requires students to adapt to the process of active socialization.

In this sense, socialization takes place in the environment of mutual active communication with the external environment, in the process of education and self-education, when a person can independently determine his goals and determine the ways to achieve them, when he realizes his worth, when he properly evaluates his place in society and develops optimally. For this, we need to pay special attention to the issue of raising a sense of responsibility in our students.
