
Innovative development of the economy of the country for economic development of the state program to support the production of relevant institutions and their resources supply is not sufficient of itself. The continuous emergence of new


1-picture. Small and micro enterprises by type of economic activity in the year 2020 share,%[8]




2-picture. Share on entrepreneurship in small regions of total industry output in the year 2020,%[8]
