In the Netherlands, an increasein blood clotting was found in 38% of 184 patients who fell into intensive care, and almost athird of them had thrombi. Kidney Although the coronavirus primarily damages the lungs, but in some patients the infectionalsospreads to the kidneys. According to the results of a sample study in China, 27% of 85 patients who applied to Uhanhospitals with coronavirus had kidney problems.

According to another study, when the urine of almost 200 hospitalized patients in Hubei and Sichuan provinces was examined, a protein confirming infection was detected in 59% of cases and blood signaling severe renal concussion in 44% of cases, in addition, the risk of deathinpatients with acute renal failure (O'bye) was five times higher than in ordinary patients withCT and MSKT methods in determining the diagnosis of pneumonia with coronavirus.
