The management of higher education institutions is carried out based on the legislation of the Republic of Uzbekistan and the regulations in question.

The direct management of the higher education institution is carried out by the rector. The rector of the state higher education institution is appointed by the Cabinet of Ministers of the Republic of Uzbekistan, and the rectors of non-state higher education institutions are appointed by the founders. The rector bears full responsibility for the results of the work of the higher educational institution. According to the legislation of the Republic of Uzbekistan and the Charter of the higher education institution, the rector operates in all bodies and organizations on behalf of the higher education institution, owns the property in the established tart, makes contracts, provides credentials, opens the account of the higher education institution in the bank and is a loan manager.

The multi-level content of higher pedagogical education is two levels in our conditions model:

- carried out in general (base-Baccalaureate and full (Graduate) form, each is autonomous to itself;
- has the appearance of a holistic system;
- fully meets the requirements of the market economy;
